I acknowledge receipt of this email.

I find it inexcusable and disturbing that anyone, who considers themself a trusted servant of a 12 step fellowship would use such tactics to cause harm and strife to the very fellowship that they claim to be in service to. If anyone has put the reputation and legal non-profit status of UAGSB Inc in jeopardy it is this GSB, by disregarding its own bylaws and the State of NY by operating with only 2 ratified trustees for this entire year. New York State Law requires a minimum of 3 trustees, and the UA Bylaws require a minimum of 4. The damage done to this fellowship as a whole and the newcomer alone by seeing the public conflict and controversy that continues with the letters in red ink on the front page of the UA website cannot be measured, however it may still be possible to reverse.

As a recovering underearner in this program since 2011, working the steps with a UA sponsor, studying the traditions and concepts and and using the many tools of this program, I have overcome time vagueness, divorce, homelessness, become solvent and gained incredible support from my fellows in dealing with a life threatening illness, and the death of both of my parents. Giving service and practicing the principles I am learning by working with others has been immensely uplifting, satisfying and an incredible opportunity to learn how to "play nice with others even when we disagree". It continues to be an honor and a privilege to serve my group, and work with many of the members of the two GSB Committees I participated in for most of this year. I have served on the GSB Literature Committee (before its abrupt transition less turn over of leadership), and the Service Structure Committee, as well as the GSRC and several GSRC working groups. I am appalled and ashamed however by the actions of this GSB. As this is a spiritual program, and as is my practice I will continue to pray for all of you. May G-d bless you and all of UA.

The great importance the Board is placing on the feared legal risks are antithetical to 12 Step principles. The certificate of incorporation has, in terms of the upside down triangle, effectively nothing to do with the fellowship itself. It is a tool that allows the GSB to serve the fellowship as stewards to the fiscal and legal necessities of the fellowship's operations, as DICTATED BY THE FELLOWSHIP. Their responsibilities are in service TO the Fellowship and recovery first and in service to the corporate entity only insofar as that entity serves the fellowship and recovery.

The GSB has not shown up in service to the groups or the other service arms of the fellowship and it has not shown up in a spirit of recovery. Indeed **it has withheld the very service which is the sole purpose for which it exists**. It is only for this reason that there is need for other groups to fund the WSC. The WSC has been showing up open to and in dialog with the broadest part of the fellowship. Additionally, it *was* (before becoming part of the GSRC) and the GSRC *is*, a group in service to the whole fellowship. As with all groups, it is autonomous and, according to the Traditions, self supporting through it's own contributions...and, free to share those contributions in service to other fellows.

Dear GSRs, GSR Alternates, and UA Group Members,

We acknowledge and appreciate the GSB's concern for the integrity of the UA Fellowship, insofar as they have been entrusted to follow certain laws and protocols related to the non-profit corporate identity associated with UA. We feel in good conscience, however, that our actions have not done anything to undermine or endanger the legal standing of our Fellowship.

To the contrary, we have worked in good faith to foster global inclusivity and ensure that our Fellowship's group conscience has the opportunity to be expressed in the manner provided by our Bylaws, which is the World Service Conference. Our efforts to date have been devoted to the empowerment and growth of the Fellowship, building on the structures, work and actions of those who came before us. And just like all the groups and intergroups in UA, we remain autonomous and committed to being self-supporting through our own contributions, in support of the recovery of our members worldwide.

It is with deep and heartfelt pain that we have collectively seen the current Board acting against the Traditions and Concepts of our Fellowship, insofar as they have chosen to act from a model of top-down authority, governing by edict, rather than leading through engagement and open communication. The majority of those who have been working at the World Service level, dedicating their time and energy in service to the growth and advancement of UA, have experienced the GSB as actively undermining their efforts, rather than being a source of support and encouragement.

It is for these reasons that we strongly believe in the need to hold a World Service Conference 2021, in alignment with the Traditions and Concepts of the Fellowship and our "upside triangle" model of service, which puts the group conscience of our Fellowship at the top of the hierarchy. The overwhelming "straw-poll" consensus of the participants who attended the GSRC meeting after the Zoom training on October 30, 2021 was to continue with the planning and execution of the WSC 2021, consistent with the prior vote at our October 10th regular GSRC meeting.
