III. Welcoming Notes by GSR Committee Chair, George, & Co-Chair, Fred

Hello everyone, my name is Fred, GSR for the Sunday Beginners Meeting and your Co-Chair for our Committee. On behalf of our Chair, George G and myself, I want to welcome everyone to the meeting.

World Service Highlights. We encourage you all to report to your groups a brief GSR Committee Report. We are posting on the *uagsrc.org* website a monthly sample report of World Service highlights. I'll read an excerpt now from our current report:

"Updates Regarding the Previous Board.

- The outgoing GSB to date has not been willing to mediate on issues with the GSR Committee or the newly-elected Trustees. The latest development is that on June 5, 2022, the old Board voted one of their members, Rina, off the Board. She was the only GSB member in favor of mediation and resolving the differences between the WSC-Approved Committees and the GSB. As a result of their action, the Board no longer has a quorum according to our GSB Bylaws.
- Background: The outgoing Board, which has 2 ratified members and 1 non-ratified member, has not agreed to resign from their positions as of this date, despite the **Motion to Reorganize the GSB** that was passed at the Special WSC Convocation on February 12 with 96% in favor. Nor have they agreed to our latest invitation to mediate sent on April 10, 2022, with a follow-up letter sent on April 25."

GSRC Motion Today. The foregoing was given in part to give you some background for our Agenda item today on next Steps regarding the previous GSB.

- **Streamlining Our GSRC Meetings.** We received several suggestions for streamlining our meetings after our last meeting. Thank you to all for your suggestions. We began trying out the suggestions at our May 2022 meeting and will continue to do so at this meeting and at upcoming meetings, or they will be referred to our Group Inventory Subcommittee for placement on the Group Inventory Survey.

A. Motion to approve the virtual WSC 2022 on Zoom being prepared by the WSC Planning Committee.

Passed by vote of acclamation.

Background: The motion to prepare a virtual WSC 2022 on Zoom was unanimously approved by the WSC Planning Committee. The outgoing Board, which has 2 ratified members and 1 non-ratified member, has not agreed to resign from their positions as of this date, despite the **Motion to Reorganize the GSB** that was passed at the Special WSC Convocation on February 12 with 96% in favor. Nor have they agreed to our latest invitation to mediate sent on April 10, 2022. The GSB is charging \$500.00 per person to register for their WSC on Zoom, rather than the usual cost of \$50.00 for our World Service Conferences, and has not invited the GSRC and other WSC-Approved Committees to present motions at their conference, so we need a Conference which will allow us to present our motions in service to the fellowship and our recovery. Even if we attend the WSC 2022 prepared by the GSB, it does not confirm that our voice will be honored as binding.

Note: The old GSB's WSC will be held on October 21-23, 2022.

Hello Everyone,

The subcommittee is currently focusing on the UA GSB Inc. Bylaws. The GSR Committee tasked our subcommittee with studying the UA GSB Bylaws and making recommendations to the full committee for possible inclusion on the Agenda of the UA WSC 2022 that is being prepared by the WSC Planning Committee.

Our Subcommittee met on Saturday, June 11, 2022 on Zoom. There were 4 GSRs and one newly-elected Trustee, in attendance: Jessica, Dena, Peter, Debora and Seth.

Last month we passed a "Motion to recommend retaining an attorney who specializes in New York Not-For-Profit Corporation law to review and edit the UA GSB Bylaws once the Bylaws, Concepts and Charter Subcommittee has made its recommendations and identified issues."

In order to implement that motion, we passed a motion yesterday to request a GSRC budget for July 2022- June 2023 for legal consultation regarding the Bylaws revision special project. We will be consulting with our GSRC Interim Treasurer regarding the amount to include in the proposed GSRC Spending Plan for July 2022- June 2023.

We continued discussion on a "Motion to include a provision in the Bylaws that in the event of a disagreement between the GSB and the voting members of the World Service Conference, that there will be a special WSC Convocation to resolve the conflict."

We decided to encourage greater participation on the Bylaws subcommittee from people in UA who are knowledgeable about Bylaws. It's not necessary for these people to be GSRC members.

Hello, I'm Peter, the Co-Chair of the WSC Planning Committee and the GSR for the UK Intergroup.

I'll report first on the February 12 WSC Special Convocation Minutes. The Minutes were sent out for final approval, and the deadline to vote is Tuesday, June 14. We would like to encourage all of the voting members to vote as soon as possible. Debora or Jessica will now put a link to the voting form into the Chat.

Next I will report on our WSC PC meeting on June 5th. Eight UA members were in attendance, including three new members, Rina from New Jersey, Akhi and Nancy P.

At our meeting, we passed a motion to approve the World Service Conference 2022 on Zoom. We also passed a Motion to approve 2 sets of alternative dates (Oct 28, 29, 30, November 5 & 6; or November 4, 5, 6, 12 & 13) for the conference to be considered by the GSR Committee for approval, and then we will ask for confirmation from all WSCA committees and the Newly-Elected Trustees. Thank you, George and Fred, for putting this vote on the Agenda for our meeting today. Subsequent to our meeting, two GSRs suggested that we have another option with the following dates: October 1 & October 2 and October 7, 8 & 9. Jessica and I reviewed our timeline and think it is doable, so those dates will also be included in the vote today.

Finally, we approved a Spending Plan for the WSC 2022, which is attached to the reminder email for today's GSRC meeting. The estimated income is \$4,600.00 based on 92 paid registrants paying a \$50.00 fee, which was the number of members registered at the WSC 2021. Our expenses are estimated at \$2,922.00. Compare this to the WSC planned by the GSB, which estimates their expenses at \$3,150.00, and they are charging \$500.00 per person.

We are now putting a link to the <u>Topics of Concern Survey</u> in the Chat and encourage all of the GSRs to take it to their groups and have group conscience votes to let us know their concerns and ideas for the fellowship as a whole relating to Literature, Service Structure, Finance, the Groups, the GSB, and so forth. Individual UA members may also complete the Topics of Concern Survey.
